



# Importing Personal Property Into

## Senegal

### IMPORTING HOUSEHOLD GOODS AND PERSONAL EFFECTS

#### REQUIRED DOCUMENTS:

- ✓ Packing list in French
- ✓ Copy of valid passport
- ✓ Certificate of Change of Residence/Moving Certificate
- ✓ Original rated bill of lading (no express release accepted)/AWB
- ✓ Original inventory in French, dated, valued and signed by the shipper
- ✓ Invoices for the electrical and hi fi appliances and for all the items bought less than 6 months before the shipment's arrival
- ✓ Resident or working permit or letter from the employer explaining that the client is starting a new contract
- ✓ Non sale certificate (declaration of honor that the shipper will not sell the household goods)
- ✓ Insurance Certificate

#### **Note:**

- All documents must be express mailed 15 days before shipment's arrival in order for the shipper's employer to apply for the possible duty free exemption certificate
- Used Household Goods are duty free if they have been in the owner's possession for at least 6 months. Items must look "used" and not contain any new wrappings.
- Customs will only allow 1 item of each type per shipper (i.e. 1 freezer, 1 VCR etc. The second items will be taxed.

- Satellite dish are considered luxury products and will be taxed
- Only one month's supply of washing products/detergents are allowed
- Almost all removal shipments are opened and checked by customs

#### IMPORTING MOTOR VEHICLES:

- All documents must be received by destination agent 1 month before the shipment's arrival.
- Chassis number and weight of the vehicle must be stated on the OBL.

#### REQUIRED DOCUMENTS:

- Original registration card
- Original OBL/AWB
- Non sale certificate (declaration of honor from the shipper that he/she will not sell the vehicle during the coming two years)
- Certificate of change of residence/transfer letter
- Copy of Passport
- Car's Invoice
- Insurance Certificate

#### RESTRICTED/PROHIBITED ITEMS:

- Firearms and ammunition
- Illegal Drugs
- Alcohol (must be accompanied with statement of "fond de cave", indicating that shipment contains less than 30 bottles)
